The ESSER III Plan was on the Board agenda for discussion and public comment on 09/14/21, 09/23/21, 10/12/21, and 10/26/21. The meeting on 09/23/21 was a study session in which the district consulted with the Hoopa Valley Tribe on concerns regarding CoVid safety protocols and coordination of services.

On 10/14/21, the ESSER III Plan was part of the Indian Policies and Procedures Task Force meeting, in which the Superintendent, the Secretary to the Superintendent, and the Director of Indian Education were in attendance.

Student input from the high school was received through surveys.

Each school site sent out paper copies of a survey soliciting input from families.

Staff contributed to the development of the plan by assessing the needs of the district that could be fulfilled through this plan.

A working group, in collaboration with Two Feathers Native American Family Services, gave input regarding the coordination of mental health and social-emotional supports.

Drafts of the ESSER III plan were sent to union presidents, trustees, and tribal education departments on 10/20/21 and 10/22/21.

The need for continued access to technology devices and internet connectivity was present in consultation with the Board, the IPP Task Force, and staff.

Students identified that they would prefer to have academic support to mitigate learning loss through in-person, after school tutoring over on-line academic support.

Consultation with staff, in particular analysis of our Facilities, demonstrates that there are a number of facilities updates that need to be made in order for us to ensure a quality physical environment for student learning. Providing HVACs for all classrooms is critical for continuous learning. During wildfire season, we are unable to conduct class outdoors, and high quality indoor air systems allow for safe in-person indoor instruction. Having back-up generators at all sites is an imperative for us to have continuous indoor instruction, allowing for the continued running of air purification and heating systems and educational technology.

Stakeholder engagement through the LCAP development indicated that a community priority is core academic instruction, with a need to focus on English Language Arts. Contributing information from the LCAP is the seriousness of concerns across stakeholder groups for the mental health. The working group identified the need for the coordination of the many services that are already available in our district.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - Tracking student attendance and improving student engagement in distance education;
