School Facility Conditions and Planned Improvements

Weitchpec Elementary School was built in 1969. Our school provides a clean and safe environment for students and staff. The school is kept in good repair by our district's maintenance crew, and facilities are cleaned daily.

Weitchpec School is a small, rural site located in Orleans, California. It consists of two classrooms, an office and small kitchen. Weitchpec School consists of kindergarten through third grade; there is one teacher and a literacy paraprofessional who is also the grounds supervisor and resource aide. The school also has itinerated support: a Yurok language teacher, music teacher, resource teacher, technology support person and counselor.

A large modernization project was just completed involving a new playground, new windows and Americans with Disabilities Act (ADA) compliancy via new classroom sinks and cabinets. A new playground and fence were also installed.

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests. 2021-22 School Safety Plan

The school safety and emergency/disaster plans were revised and updated in in May 2016 in accordance with state requirements. Our plans are produced by the North Coast Schools' Insurance Group and the Humboldt County Office of Education and are posted in our school office.
